WALK-IN INTERVIEW FOR THE POST OF SENIOR RESIDENT

*Deep Chand Bandhu Hospital invites application for a Walk-in-interview for filling up **One (01)** vacant post of Senior Resident in the Department of **ORTHO** on Adhoc basis. Only candidates who fulfil the eligibility criteria as per Residency scheme may appear before the interview panel on **28-02-2017 from 9:30 A.M. to 012:00 NOON** with their original documents alongwith the photo copy of the following documents :-*

- 01. **Qualification** : Post Graduate Degree (MD/MS/DNB, Diploma) in the concerned disciplines from a recognised university/ institution.*
- 02. **Age limit**: 35 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only).*
- 03. **DMC Registration Certificate.***

Tenure: The appointment will be initially for a period of 89 Days or till the joining of Senior Resident Doctors through centralized recruitment on regular basis. The extension will further subject to satisfactory performance, work and conduct report from concerned HOD.

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of Delhi with the following relaxation :-

1. Upper age limit for eligibility for SR will be 40 years.
2. In case of non availability of fresh candidates, candidates who have completed 03 years of Residency as Senior Resident shall also be allowed to appear in the interview.
3. Separate merit lists for fresh candidates and for others (i.e. those who have competed 3 years of Sr. Residency) would be prepared.
4. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
5. Reservation of Person with Disability will be as per Government Rules.

Other conditions/requirements:-

1. The service of Senior Residents shall be governed by residency schemes of Govt. of India/Civil Services (Temporary Rules.)
2. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
3. The posts will be filled up in phases as per availability of vacancies. The number of vacancies as shown above may subject to change.
4. Appointment shall be subject to verification of certificates.
5. No TA/DA will be paid for appearing in the interview.
6. The appointment may be terminated at any time by 7 days notice given by either side i.e. the appointee or the appointing authority. No notice is required if service are terminated on disciplinary grounds.
